Big Changes:

- Final paystub required for each W2 job to verify non-taxable overtime and tips
- New Vehicle Purchases- VIN Eligibility Required
 - If you purchased and are financing a new vehicle in 2025, you must verify the vehicle qualifies
 - Nhtsa.gov/vin-decoder
 - Please bring your VIN and interest paid on the vehicle in 2025
- IRS is phasing out paper checks for both refunds and payments. Bank information will soon be required for filing
- This is the final year to claim energy efficient tax credits- windows, doors, solar, etc.

- ✓ APRIL 15TH, 2026 is the tax filing deadline and extension filing deadline for INDIVIDUALS.
- ✓ MARCH 16TH 2026 is the tax filing deadline for PARTNERSHIPS, CORPORATIONS AND LLC'S TAXED AS A PARTNERSHIP OR CORPORATION. IT IS ALSO DEADLINE FOR THOSE COMPANIES TO FILE EXTENSIONS.
- ✓ Note: When filing an extension, penalties and interest will apply to tax amounts due. Filing an extension is only an extension to File – **Not an extension to pay.**
- ✓ All supporting documents should be brought to your appointment to ensure timely completion of your Tax Return preparation and filing process.
- ✓ **Documents must be dropped off by March 31st or an extension will be filed for you. We cannot guarantee it will be done by the April 15th deadline. We will need a copy of your driver's license for dropped off returns, as well.**
